

CORPORATE EQUIPMENT USER AGREEMENT

Floor Curling, Express Rink & Street Rink Equipment

Corporate bookings refer to hires made by businesses or organisations for use during events, workplace activities or any similar corporate or personal use situations.

1. Equipment Provided:

Scottish Curling agrees to loan the following equipment to the Hirer: [adapt as necessary]

- Floor Curling Set (8 stones, 2 house mats, 1 pusher stick)
- 10 metre mat – use alongside Floor Curling Set above.
- Express Rink – Inflatable (Rink, mat, 8 stones, 2 pusher sticks, trolley, brush, inflator/deflator pump). Please note: Hirer may require extension lead.
- Pro Street Rink Equipment (boards, 8 stones, delivery sticks)
- The final inventory shall be confirmed by both parties at collection.

2. Hire Period

The Hirer may use the equipment from [Start Date] to [End Date].

All equipment must be returned by [Return Date], unless otherwise agreed in writing.

Late returns may be charged at the applicable daily hire rate.

3. Costs & Fees:

3.1. Hire Fees:

All prices are inclusive of 20% VAT.

3.2.Replacement Costs:

The Hirer agrees that any missing or damaged equipment, not identified at the time of collection, will be charged at the following replacement costs:

4. Transport & Setup Requirements:

- Equipment must be transported using a suitable vehicle with adequate space and secured properly to prevent damage.
- Pro Rink and Express Rink must be transported flat; van or similar vehicle required.
- Equipment must not be dragged, dropped or stacked in a manner that may cause damage to components.
- The Express Rink and Pro Rink require a minimum of 2 adults for safe handling, setup and takedown.
- The Express Rink must only be inflated using the supplied pump and monitored during use.
- If weather conditions are unsafe (high wind, rain, or extreme heat), outdoor use of the Express Rink and Pro Rink are prohibited.
- All equipment must be returned clean, dry, deflated (if applicable), and properly packed.
- Collection and return of the equipment shall be to the Scottish Curling Office (Cairnie House, Ingliston Showground, Newbridge, EH28 8NB) unless otherwise agreed.
- All transport costs associated with the hire of the equipment are the sole responsibility of the Hirer.

5. Use & Care:

- Equipment must be used only on appropriate surfaces:

- Floor Curling: smooth, dry indoor surfaces
- Express Rink and Pro Rink: smooth, dry indoor/outdoor surfaces, including grass
- Equipment must not be exposed to moisture, sharp objects or excessive heat.
- The Hirer agrees not to modify, disassemble, permanently mark, or sub-loan the equipment.
- Participants must be supervised at all times.
- The Hirer agrees to use the equipment responsibly, in a safe and dry environment, and only for its intended recreational or program use as per application.

6. Damage or Loss:

The Hirer accepts full responsibility for any loss or damage (beyond normal wear and tear). In the event of damage or loss, the Hirer agrees to:

- a) Repair or replace the equipment, or
- b) Reimburse the Lender for the cost of repair or replacement based on costs listed above (as determined by the Lender).

Payment must be made within 14 days of notification.

7. Liability & Insurance:

- The Hirer assumes full responsibility for the safe use, storage and handling of the equipment.
- Scottish Curling accepts no liability for injury, loss, or damage arising from use of the equipment. The Hirer must hold appropriate public liability insurance and provide evidence upon request. in place.
- The Hirer agrees to indemnify and hold the Lender harmless against all claims arising from equipment use.

8. Return Condition:

- All equipment must be returned clean, dry, and in the same condition as received.
- The Lender reserves the right to inspect equipment within five working days of return.
- Any missing or damaged items will be charged at the replacement costs listed above.
